## NEW BUSINESS

- 1. Dauphin County Comprehensive Plan The Dauphin County Board of Commissioners recently adopted an update to the plan.
- 2. The Tri-County Regional Planning Commission has prepared a Model Zoning Ordinance and a Model Subdivision & Land Development Ordinance to aide municipal officials with their ordinances.
- 3. Comcast will consolidate its Millersburg and Lykens office to a new location in Upper Paxton Township.
- 4. Joe Hayden's Auction Chairman Alan Loesch made a motion to impose a temporary parking prohibition on Carsonville Road from Back Road south to the top of the ridge from Friday, September 5, 2008 at 4:00 pm until Sunday, September 7, 2008 at 7:00 am to assure the safety of people attending a public auction scheduled for that time and to assure that Carsonville Road remains open, passable and safe for all traffic, including emergency vehicles should they need to use that road during that time. Supervisor Keith Crum seconded the motion. Motion carried 2-1.
- 5. Township website Chairman Alan Loesch made a motion to contract with Travis Enders to set up a Township website with an upfront cost of \$154.70, \$15.00 per hour maintenance fee, and a yearly fee of \$64.75. Vice Chairman Greg Gusler seconded the motion. Motion carried 3-0.
- 6. COG Report A procedural audit of the Upper Dauphin Income Tax Office is underway. The first financial audit will be in September with the second to follow in October. The next advisory board meeting is scheduled for November 24, 2008.

UCC Appeals Board UCC Inter-municipal Agreement - Comments are due by August 15, 2008.

## ADMINISTRATIVE/TAX ASSESSMENT PERMITS -

The Board approved permits for Jodi & Aaron Ellis for a detached garage, and the Fire Company for an addition to the Fire House.
